**EXECUTIVE ORDER NO. 06 – 2025**

**AN ORDER TEMPORARILY CLOSING THE SALDUA BRIDGE**

**WHEREAS**, Section 21 (c) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", Local Chief Executives through written order, may temporarily close both national and local roads during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications and waterworks projects;

**WHEREAS**, Article 45 (a) (3) of the IRR of RA 7160, states that, the temporary closure of road is allowed when public works projects or activities are being undertaken for a period as may be determined necessary for the safety, security, health, or welfare of the public or when such closure is necessary to facilitate completion of the projects or activities;

**WHEREAS**, the Municipal Government of Polomolok through the Department of Public Works and Highways (DPWH) will undertake a replacement and construction of the SALDUA bridge, thus, the Municipality needs to close the affected road;

**NOW, THEREFORE, I, HON. BERNIE D PALENCIA**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby order the following:



**SECTION 1. TEMPORARY CLOSURE OF ROAD.** The Saldua Bridge more particularly the portion approaching and/or along the bridge shall be temporarily closed on March 24, 2025 to October 2025 or until such period as may be necessary to complete the replacement and/or construction project.

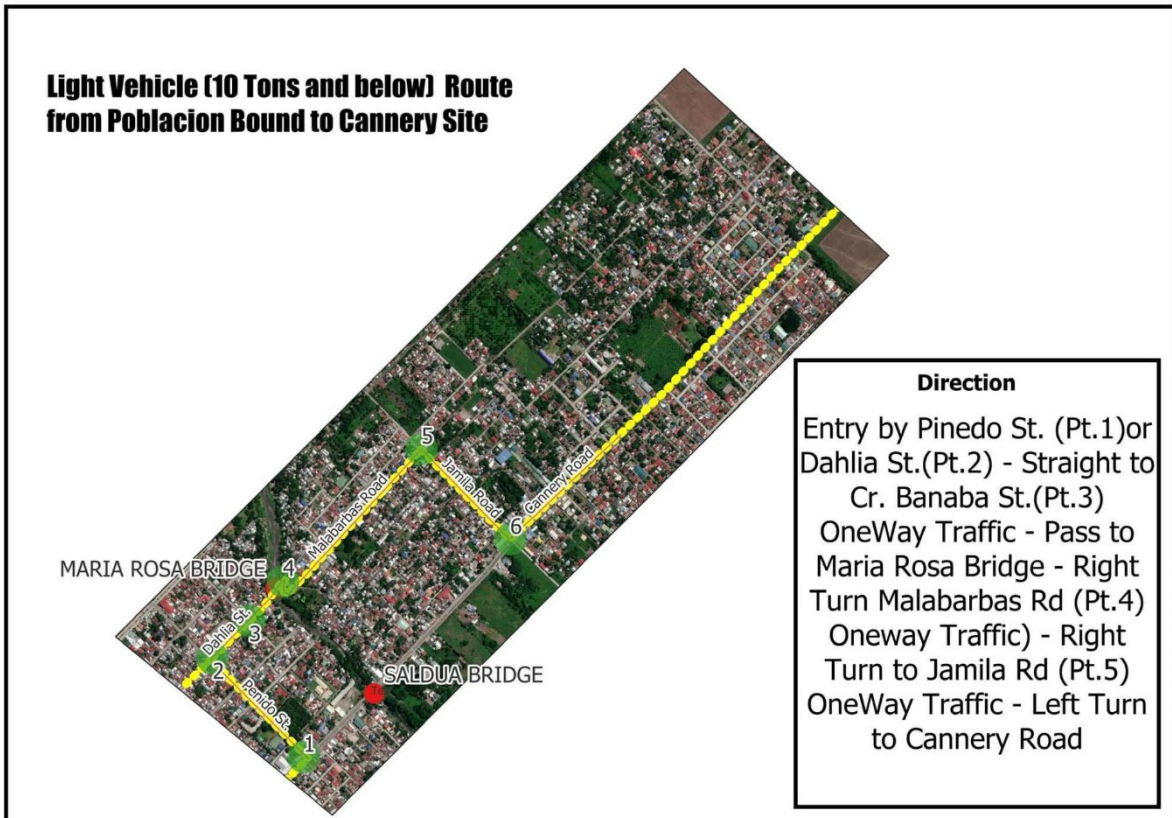
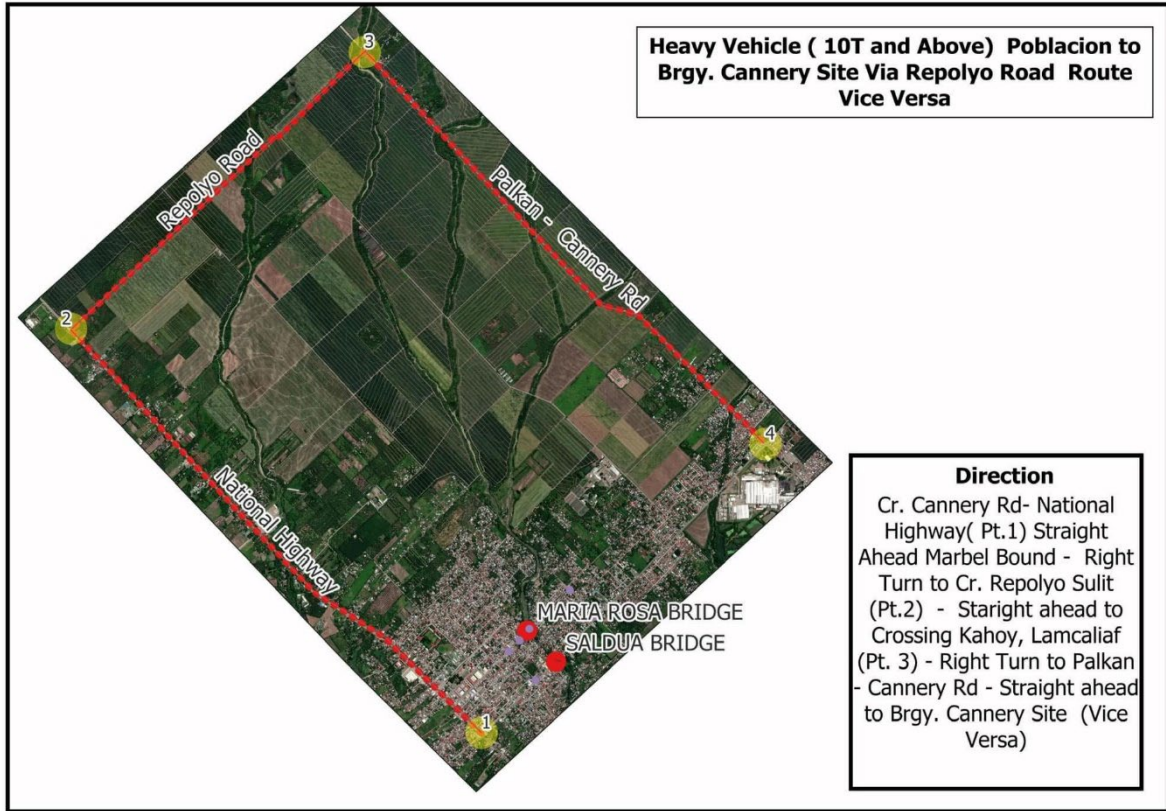
**SECTION 2. ALTERNATE ROUTE.** All vehicles going to and from Cannery Road are hereby advised to use the available alternate route provided by the Municipality through the Municipal Planning and Development Office.

**SECTION 3. IMMEDIATE DISSEMINATION.** The Municipal Administrator's Office and the Municipal Disaster Risk Reduction Management Office are hereby directed to disseminate this order.

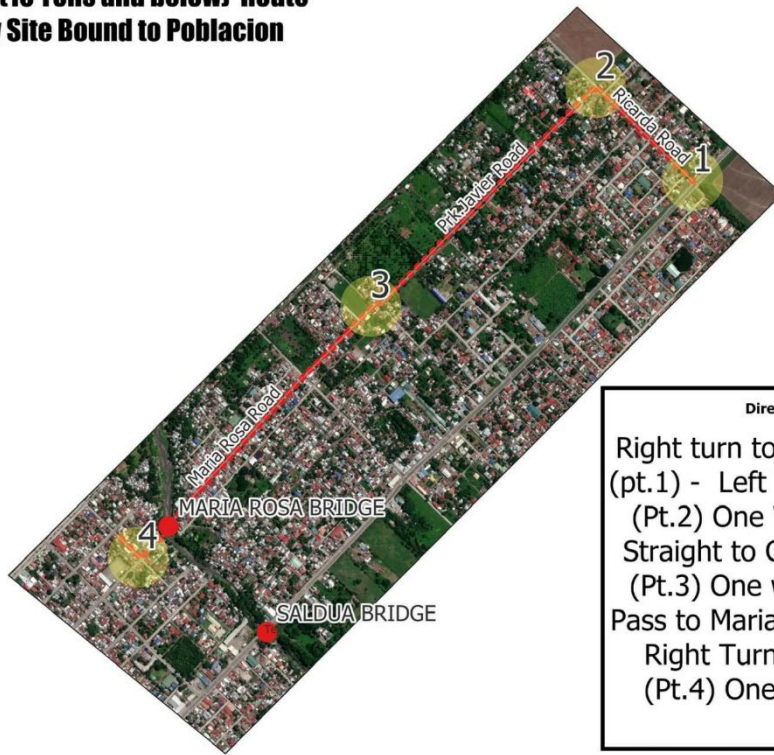
**SECTION 4. EFFECTIVITY.** This order shall take effect on March 24, 2025 until October 2025 or until such period as may be necessary to complete the replacement and construction of Saldua Bridge, Polomolok, South Cotabato.
